



### Rights Respecting School

Ricky is our travelling Rights Mascot who helps our Early Years and Key Stage one children learn about their Rights. Over half term, Luca one of our pupils collaborated with his mum and grandma to kindly make him a school uniform so he could look just like us at St Edmunds and keep him warm during the colder days! This links to Article 27 of the United Nations Convention on the rights of the child (UNCRC) about having the right to food, clothing and a safe home. Luca confidently spoke to the whole school on Friday to tell us all just what he and his family had done to make the uniform.

As a Rights Respecting School, we spend time talking about the rights that each of our children have. We also hope to see that our children feel empowered to exercise their rights too. One of our Yr6 pupils demonstrated just this, taking time to write to our local MP Jo Churchill last half term. She was questioning why it is not a compulsory aspect of schooling in the UK to learn survival skills. We were proud to see Anna exercising her right to have her voice listened to (UNCRC Article 12).

Anna was delighted to receive an initial response from Jo, acknowledging the importance of her question and noting that she would consult other colleagues in the DfE. Given the responsibility that the government have as duty bearers, ensuring that all children in the UK access the rights that they are entitled to, we hope that the voices of many children such as Anna, who take time to ask questions and to hold them to account for the work that they do, have a positive impact on changes that they experience in the future.

## Local Welfare Assistance Scheme

If you are currently experiencing financial hardship, the Local Welfare Assistance Scheme (LWAS) could be of help for your family. Financial hardship could mean you are struggling to afford the basics, such as food, heating, clothing and fuel, or to pay your household bills. The scheme is not intended as emergency support and only one award can be made to an eligible household in a 6-month period. Successful applicants will receive a BACS payment directly into their bank account or a Post Office cash out voucher that can be redeemed in store. The application process for this is done online and only takes 15 minutes.
